Certificated Training Programmes :

IOSH Managing Safely – This course is designed for staff with supervisory or management responsibilities for ensuring best practice within the organisational framework and compliance within relevant legislation. We also offer the 1-Day refresher course for this programme.

IOSH Working Safely - This course aims to instruct and inform staff in Working Safely issues to ensure that their actions contribute to health and safety in the workplace and that individual responsibilities are clearly understood. The course is ideal for use as part of an induction program but can also form part of ongoing training.

IOSH Managing Safely Refresher - This is a one-day course for delegates that have attended a Managing Safely course within the previous 3 years. The course concludes with a formal examination based on assessment of skills and underpinning knowledge. Successful candidates are awarded the IOSH Managing Safely certificate valid for a further 3 years

NVQ Occupational Health and Safety (level 3 & 5) – Accredited programmes developed for candidates working in the general area of health and safety, those managing a health and safety function and managers having a significant responsibility for safety.
